Approve appointment of a City Council Member or a City Manager to the Visit Santa Cruz County Board of Directors for a two-year term to expire June 30, 2027.

Background

Visit Santa Cruz County (VSCC) is a private, non-profit corporation serving as the official visitor marketing entity for Santa Cruz County. VSCC works to enhance tourism, the visitor experience, and the area economy by positioning and promoting Santa Cruz County as a year-round visitor, conference and film destination.

VSCC is governed by a diverse 25-member Board of Directors. The Board is composed of representatives from various geographic regions throughout the county, including 13 lodging seats and a cross-section of representatives from business, cultural, governmental and organizations affiliated to the travel, tourism and hospitality industry.

Board member responsibilities include participation in the governance organization, general advocacy for the tourism industry and active participation at board meetings, held six times a year. Meetings take place at 3:00 p.m. on the last Wednesdays of January, March, May, July and September. November and December meeting dates vary due to the holidays.
