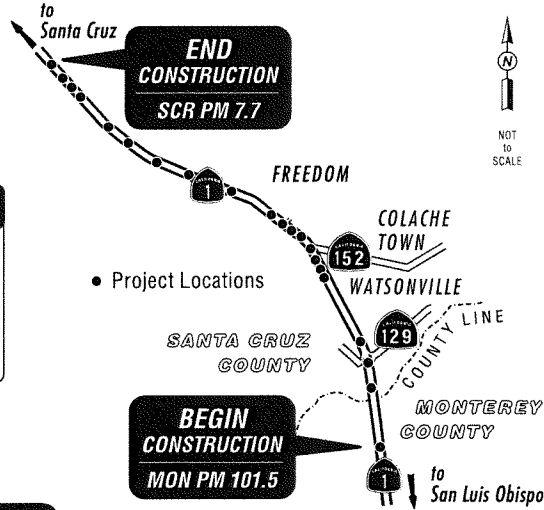

PUBLIC COMMENT PERIOD

Comments will be accepted from June 28 to July 30, 2022. If there are no major comments or requests for a hearing, Caltrans will proceed with the project's design.

WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to repair or replace 18 culverts to improve existing drainage systems on State Route 1 in Santa Cruz County from post mile 0.0 to post mile 7.94. The project would also add six maintenance vehicle pullouts, one changeable message sign, one location for paving beyond the gore, multiple locations for traffic monitoring and management systems, and highway lighting at six locations along State Route 1 from post mile 101.50 in Monterey County to post mile 7.94 in Santa Cruz County. Project activities would occur in multiple work locations along State Route 1.

WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show the project would not significantly affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Mitigated Negative Declaration. This notice is to inform you of the preparation of the Initial Study with Proposed Mitigated Negative Declaration and of its availability for you to read and comment on. This notice also offers you an opportunity to request a virtual public hearing.
