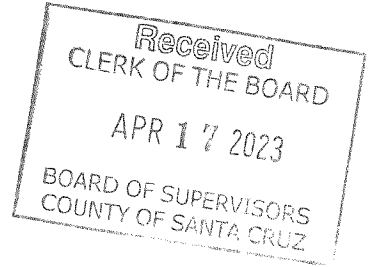

Notice of Availability of Recirculated Partial Draft EIR**

**Project Title:** Santa Cruz Wharf Master Plan

**Project Location/Address:** Santa Cruz Wharf at Beach Street

**Project Description:** The project consists of adoption and implementation of the Santa Cruz Wharf Master Plan and construction of the two following projects recommended in the Master Plan within 2 to 5 years: Entry Gate Relocation and the East Promenade Renovation. The Wharf Master Plan includes policies and actions, recommendations for Wharf expansion, including new construction and improvements, circulation/parking improvements, and design standards for buildings on the wharf. This Recirculated Partial Draft EIR adds a new analytical Recreation section that considers the impacts of both the implementation of the Wharf Master Plan, as well as construction of the first two projects to be implemented pursuant to the Plan—the Entry Gate Relocation and the East Promenade, on recreational facilities and uses, including consistency with plans and cumulative recreational impacts. This document also adds minor revisions and clarifying statements to Section 3, Project Description, as a result of public hearings conducted on the Plan in 2020. All other sections of the Draft EIR, dated March 2020 and Final EIR, dated September 2020 remain unchanged.
