Project Name: Mountain Charlie Road PM 1.43 and PM 1.63 Culvert Replacements

Project Location: The two project sites are located on Mountain Charlie Road at post mile (PM)

numbers 1.43 and 1.63 in unincorporated Santa Cruz County.

Project Description: The proposed projects involve the replacement of cross culverts at two locations on Mountain Charlie Road.

PM 1.43: Replace an existing rusted out 12" cross-culvert with a new 18" culvert across the width (15 feet) of a two-lane roadway at a depth of 3 feet beneath the road surface. Using an excavator or backhoe, the contractor will remove the existing culvert, excavate a 36" trench in the road and install the new culvert. The outlet will be fashioned to lie on the surface of the down-slope with a "T" cap on the culvert outfall to dissipate stormwater runoff. The trench will be backfilled with 2 sack slurry and the contractor will repave the area with a 3" layer of asphalt concrete.

PM 1.63: Replace an existing 24" rusted out cross-culvert with a new 24" culvert across the width (15 feet) of a two-lane roadway at a depth of 4 feet beneath the road surface. Using an excavator or backhoe, the contractor will remove the existing culvert, excavate a 36" trench in the road and install a new culvert. The trench will be backfilled with 2 sack slurry and the contractor will repave the area with a 3" layer of asphalt concrete.
