Project Description: The proposed project involves replacing approximately 262 feet of existing sewer pipe within Capitola Rd at Clares Street to repair a badly deteriorated section of sanitary sewer main. The project includes removing 262 linear feet of existing 6" deteriorated sewer pipe and replace it with 262 linear feet of new 8" sewer pipe. The construction method is open cut trenching within the existing paved road and center divider. The project includes cutting a trench in the existing roadway, removing the existing deteriorated pipe, replacing it with new pipe, and replacing pavement associated with open cut trenching. One street tree (12" dbh *Sycamore* sp.) that occurs in the center divider will be removed and replaced in-kind. Construction will occur entirely within the existing road right-of-way.
