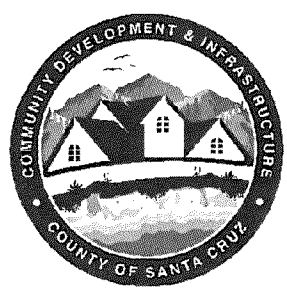

Project Description: The subject ordinance will enact and amend various sections of District Code, Title 2, Chapter 2.05, Section 2.05.110 "Contracts, Bid Documents, and Subcontracts", Title 5, Chapter 5.04, Article IV, Section 5.04.500 "Sewer Service Charge Refunds", and delete Title 7, Chapter 7.04, article VII, sections 7.04.670 "Dolphin Drive Pump Station Repayment Plan" and 7.04.671 " Soquel Drive/Freedom Boulevard Repayment Plan". These code changes improve administrative processes and streamline the District Code. Removing obsolete code sections provides for orderly, accessible regulations. The proposed amendments do not involve potential direct or indirect changes to the environment.
