## Description of Nature, Purpose and Beneficiaries of Project:

Repair, replacement and stabilization of harbor marine infrastructure damaged during storm surge waves on December 23, 2024, including, but not limited to: debris removal throughout the harbor; repair of docks and electrical utility damage; reconstruction and repair of docks and damaged end-ties; and other miscellaneous dock damage throughout the harbor. Work will require the replacement of up to 150 damaged piles and pile guides.

Emergency work is currently underway and is being completed in a manner consistent with Regional General Permit Number 5 (RGP5) issued by the U.S. Army Corps of Engineers for repair and protection activities in emergency situations, and Technically Conditioned 401 Certification of RGP5 by the Central Coast Regional Water Quality Control Board. Emergency work is necessary to restore the integrity and serviceability of damaged marine structures, protect the environment, safeguard property, ensure public safety and the navigability of harbor waters and the federal channel.
