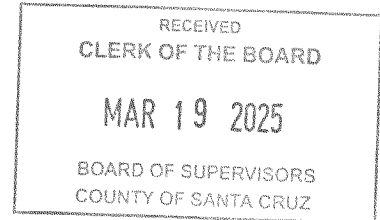

NOTICE OF EXEMPTION

Project Name: 2025 5th Ave Emergency Sewer Repair Project

Project Location: The project is located within the traffic circle at the intersection of 5th Avenue and East Cliff Drive.

Assessor Parcel No.: County Road Right of Way

Project Applicant: Santa Cruz County Sanitation District

Project Description: The proposed project involves replacement of up to 30 linear feet of existing deteriorated public sewer lines located within the traffic circle at the intersection of 5th Avenue and East Cliff Drive. During routine camera inspection of the sewer pipe, Sanitation District Staff identified that the existing sewer line in this location has a large hole and requires immediate repair. The project will be completed through conventional open-cut trenching which includes saw cutting the existing road, digging a trench, removing the existing deteriorated 6" pipe, replacing it with new 8" pvc pipe, and reconstructing the paved roadway. The project may also require replacement of an existing manhole depending on field conditions observed at the time of construction. Construction will occur entirely within the existing paved roadway.
