

Project Name: 2026 Measure D Resurfacing Project

Project Location: The project is located along various roadways in unincorporated Santa Cruz County as identified in Attachment A.

Assessor Parcel No.: County Road Right of Way

Project Applicant: Santa Cruz County Department of Community Development & Infrastructure- Public Works

Project Description: The proposed project involves pavement maintenance and repair activities along various roadways in unincorporated Santa Cruz County. Various repair treatments will be used depending on existing roadway conditions. The attached road list identifies the sections of roadways receiving improvements, and the treatment designated for each section. The primary treatment for most roads will involve isolated road base repairs (digouts) of damaged areas followed by asphalt leveling and overlay. Some roads will receive micro-surfacing seal, rubberized cape seal, rubberized chip seal followed by an asphalt overlay, or some combination of these treatments.
