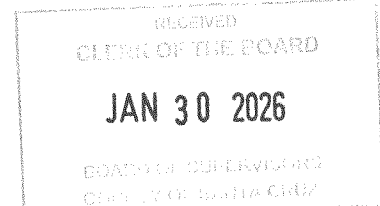

Project Description: The subject ordinance will amend Title 7, Chapter 7.04, Articles IV and X (Various Section) related to "Nondomestic Sewage Restricted," "Private Sewer Maintenance," and "Fees and Charges". This ordinance updates language pertaining to nondomestic sewage permits and increases permit fees, clarifies the responsibility for notifying the District prior to sewer lateral flushing, and increases plan review fees for at-cost accounts. These changes are intended to improve administrative processes and clarify District code and will allow the District to recover costs of plan / permit review. The proposed amendments do not involve potential direct or indirect changes to the environment.
