  - 3.1. Safe Release: August 27<sup>th</sup> to date, 6 safe releases for a total of 9 nights.
  - 3.2. New Life / Gemma:
    - 3.2. Gemma almost at capacity, 1 opening. Hiring new staff.
  - 3.3. Board of State and Community Corrections (BSCC) announced awards for Prop 47. HSA and COE each received a combined 15 million. HSA focus on transitional housing, Janus as partner. Casey Swank, Director of Substance Use Disorder Services is HSA lead.
  - 3.4. Jail Update
    - 3.4. Jail population 30 women in custody: 10 in Blaine Street; 20 in Main Jail 13 in GUnit and 7 in H Unit.

- 3.4. 6 in WRRP.
- 3.4. In G Unit, 6 are enrolled in classes.
- 3.4. In H Unit, no classes, not a programming unit.
- WRRP after care 3 women at Gemma enrolled at Cabrillo and Rising Scholars.
  - 3.4.1.4.1. Rising Scholars, Homeless Garden Project, and Goodwill giving monthly presentations at Blaine.

#### 3.5. Visitation

- 3.5. First visit scheduled in September at Blaine, did not happen because the woman scheduled had an infraction and was rehoused at Main Jail prior to visit. She is now back at Blaine.
- 3.5. October Visit, women who wanted a visit didn't make the deadline, needed to submit paperwork at least two weeks ahead. Must get family member on visiting list, must get security clearance, family member needs to call to schedule the visit. Family members did not make their call in time for the October visit. Up to guardian to make the call, also have to prove parent or guardian of child. Brochure available to family regarding visiting in Main Jail lobby. Planning to put more visiting information on the website. RounTree still waiting on body scanner for reinstating children visits.
- 3.5. IDs while in custody. SCSO staff still looking into that, waiting on DMV. Santa Barbara and San Diego counties have similar programs.
- 3.5. Netflix Documentary titled *Daughters* highly recommended. Date with dad father daughter dance with girls whose fathers are incarcerated.
