    - 3.2. Jail population: 30 women in custody
      - 3.2. Main Jail: 18 women total; G Unit 12 women; H Unit 6 women; O Unit, 3 woman.
        - 3.2.1.1.1. Blaine Street: 9 women, 6 enrolled in WRRP. One woman at Blaine celebrating High School graduation today!
        - 3.2.1.1.2. 5 on release to program list. Days on list range from 1 to 24. Two are releasable to pretrial but need a verifiable address and one doesn't have one, the other is waiting for a medical transfer.

3.2.1.1.3. 3 WRRP participants at Gemma: 1 at UCSC, 1 in Rising Scholars, and other planning to enroll in Rising Scholars.

3.2.1.1.4. Polly worked with WRRP women to help coordinate women with out of county warrants to appear in court via zoom and get warrants recalled.

3.2.1.1.5. 8-week Culinary program at Blaine Street starting where women will be able to earn serve safe certificate. Funded through a COE AB109 grant.

3.2.1.1.6. Goodwill is leading an employment readiness class.

### 3.3 Visitation

2 contact visits have taken place at Blaine Street in February and March, same mother and child. No update on when visits will begin at Rountree or when visits might open up for other loved ones in addition to children under 18.

3.4 Safe Release: 11 assessments for safe release. Vouchered 8 women for a total of 12 bed nights.
