6. New Business

6.1 Local Hazard Mitigation Plan Update

Dave Reid shared that OR3 recently received a grant for a multijurisdictional HMP plan; plan development to begin in 2025.

Tiffany Wise West – Sustainability Manager, City of Santa Cruz presented the City's new HMP. Key changes and updates include:

• Integration of the City's CAAP plan





- Incorporation of extreme heat as a threat
- Use of adaptation pathways approach (not time dependent, uses triggers and metrics; Will develop NOI for priority projects and address combos of hazards—like drought, then fire, then storm then land slide)
- Assess all assets, new strategies identified and incorporated, outreach conducted around concerns, access, and priorities
- Public review draft to open in November December
- Submission to CalOES, approval expected by summer 2025

Jake Ainsworth Chief Deputy Santa Cruz County Sheriff - Additional drone teams to be utilized during Warf to Warf; City of Santa Cruz to provide staffing in lower course areas.

6.3 Emergency Operations Base Plan – **ACTION ITEM**

OR3 staff shared:

The EOP would be going to Board of Supervisors on 9/10/2024 for approval and that CalOES stated that compared to other plans, the Santa Cruz OA plan had the fewest number of items requiring additional action to complete.

General plan-feedback from CalOES was broad around whole community planning, centered around AFN. OR3 has a meeting scheduled week of 9/9/24 to stand up DAFN workgroup made up of internal County stakeholders to brainstorm additional workgroup participants; the workgroup will participate in and review all emergency plans going forward.

Joe Kristy recommended updates to some dated-data points. OR3 stated those types of updates will occur post BOS meeting.
