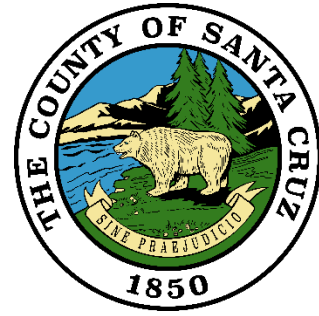


Storm Damage Disposal Guidelines

Proper disposal of storm damaged items and debris



Buena Vista Landfill and Ben Lomond Transfer Station

The following items/materials can be **accepted** at the County of Santa Cruz Buena Vista Landfill and Ben Lomond Transfer Station. Rate schedule, hours, locations and acceptance policy is available at: www.santacruzcountyrecycles.us

Refuse: Water-damaged items such as carpet, rugs, furniture, drywall, insulation, clothing, household trash, demolition debris (Buena Vista Landfill only), etc.

Recyclable Items: Water damaged appliances, mattresses, e-waste (televisions, computer monitors), metal items.

Wood and Yard Waste: Accepted at reduced rates. Must be free of refuse, dirt, treated or painted lumber, poison oak, pampas grass, bamboo, yucca, palm or root balls. Must be smaller than 8' length by 2' diameter, 4' length by 3' diameter, or 2' length by 4' diameter.

Treated Wood Waste: Small loads (less than 500 pounds per day) accepted. See:

Large loads (greater or equal to 500 pounds per day) should be disposed at ReGen Monterey Landfill.

Household Hazardous Waste (HHW): Fluorescent lights, batteries, paint, pesticides, aerosol spray can, propane tanks (less than 5 gallons), pool/hot tub/spa chemicals, cleaning chemicals, motor oil, antifreeze and other automotive products. Household Hazardous Waste is accepted at the following locations and drop-off times:

- **Buena Vista Landfill:** Wednesday, Friday and Saturday 7:30 a.m. to 2:30 p.m.
- **Ben Lomond Transfer Station:** Thursday 7:30 a.m. to 3:30 p.m.
- **City of Santa Cruz Resource Recovery Facility:** Saturday 7:30 a.m. to 3:30 p.m.

Mud, Soil and Sand

- Buena Vista Landfill: Mud should be allowed to dry and materials should not contain chemicals, refuse or organic debris, including tree branches, stumps or any rocks over 1" in diameter

GreenWaste Recovery

In addition to weekly garbage and recycling collection, GreenWaste Recovery residential curbside collection service includes three (3) bulky item (furniture, mattresses, appliances, tires, televisions, BBQs) pickups per year and four (4) "Extra Set Out" pickups per year at no additional cost. Bulky items and Extra Set Outs beyond this will be charge a nominal fee. These pickups must be scheduled in advance by calling GreenWaste Recovery Customer Service at (831) 426-2711.
