The purpose of the Juvenile Justice and Delinquency Prevention Commission is to advocate for and protect the safety and well-being of dependency and juvenile justice-involved youth and to prevent youth from becoming involved in the juvenile justice system. As a Commission, we will educate and inform our community and system leaders on the importance of positive youth development and advocate for coordinated and well-resourced systems that promote family and youth success and prevent system involvement.

In furtherance of that purpose the Commission has adopted three goal areas to guide its work over the next 2 years (2024 – 2026):

1) Juvenile Hall Inspection; 2) Positive Youth Development through the 41 Developmental Assets; and 3) Convening Stakeholders.

VI. INFORMATION ITEMS:

- Prevention: Next steps with developmental assets. Commissioner Kebebew shared the work in partnership of City of Watsonville and ABC Group recently surveyed approximately 300 youth to compile the responses which includes areas of gaps or need(s) that were shared. Hoping that the JJDPC will want to partner or co-sponsor future work and the roll-out of data.
- 2. Election of Officers in April. Vice Chair Gonzales reminded the Commissioners that they will be selecting new Officers at the April 10, 2025 meeting.
- 3. Passage of Ranch Camp proposal. Commissioner Gomez updated the group that the Board of Supervisors approved the implementation of a Ranch Camp at the same location as Juvenile Hall. Several Commissioners commented that there is a lot of opportunity for work to be done together by Probation, the Commission and other partner/community agencies and members of our County.
- 4. JJDPC Inspections (RC, JH, SYTF) involvement of all commissioners. Vice Chair Gonzales encouraged all Commissioners to participate. Commissioner Druley suggested options of actually performing the in-person inspections or perhaps in doing research to find an alternate inspection tool.



















Santa Cruz County Juvenile Hall Room Confinement: Overview January 2023 - March 2025

Dear Commissioners Brook, Gonzales, and Ruiz,

I hope this message finds you well! Commissioner Brook, it was wonderful seeing you yesterday at the statewide meeting of Juvenile Justice Commissions (JJCs) and Juvenile Justice & Delinquency Prevention Commissions (JJDPCs).

As discussed, I'm reaching out to provide you with additional information on counties that offer familial residences as a less restrictive program (LRP).

Earlier this year, our office received a similar request to identify counties with home-based LRPs. At that time, we identified at least two counties — Fresno and Kern — where youth previously adjudicated to a Secure Youth Treatment Facility (SYTF) were actively serving out the rest of their baseline term in a familial residence LRP.

In the case of Fresno County, for each youth placed in their family's residence, a six-month review hearing is held to track the progress of their case. Additionally, all youth are monitored using GPS devices, which are reviewed by the Probation Department every 30 days. Similarly, in Kern County, SYTF youth are released into the community with GPS monitoring as an LRP. In this case, the Kern County Superior Court releases the youth to general GPS monitoring, rather than to a specific residence. However, if deemed appropriate by the Court, the youth may stay with a family member. Regardless of their residence, youth placed on GPS monitoring are required to report daily to a Kern County Probation Day Reporting Center to ensure compliance with the Court's orders.

If you are interested in speaking with your colleagues at the Fresno County JJC to learn more about their experience petitioning for a familial residence program, I would be happy to connect you to their commission. Unfortunately, Kern County does not operate a JJC or JJDPC, but I can assist you in reaching out to the appropriate individuals within their Juvenile Probation Department to discuss their experiences supporting youth in familial residence LRPs.

Please let me know if you would like further assistance or additional resources on this topic. I'm happy to provide any additional information or connections that may be helpful as you continue to explore options for less restrictive programs.

Thanks so much for coordinating this for the Commission.

Here is my feedback on data:

- 1. I would like to see the JH reports/data reduced. I think that some of it is very detailed and that the JH could provide an annualized report of these items at the Inspection and the JJDPC could review these and not have them every month:
- Physical altercations overview and time, location, and day of the week
- Grievances
- Use of force
- Room confinement overview & stats
- Separate program stats
- 2. Keep that Juvenile Division and JH Data Blasts
- 3. Create a data blast for SYTF and Ranch Camp
- provide a progress report on implementation and changes as the SYTF and Ranch camps are further refined and developed.
- 4. Provide data on success of the prevention and diversion programs and recidivism rates of probation and formerly detained/incarcerated youth. This might need to be a discussion with Probation at a meeting of what is feasible/possible.

Detention Facility JJDPC Inspections for 2025– General Timeline rev. 4/2/25 (DRAFT ONLY for Discussion given there are many open issues.

(Assuming the inspection the week of August 25th, 2025)

Inspections' Approximate Timeline

- April: set inspection dates and parameters with Probation
- April/May: Confirm inspection team members and exact dates for inspection (during the week of 8/25/25)
- May: Inspection Training at the JJDPC Meeting
- June Meetings: Team reviews inspection tools and adopts methodology and sets up training for JH, SYTF and Ranch Camp. (Family interviews this year?)
- Late June: 1) Send probation list of team and detailed timeline & scope of inspection and 2) Train inspection team(Meetings) 3) Design youth and/or family surveys and assign interviewers
- July 15: Probation sends documents to each team member for their category/type of facility inspection
- August 1: Members' review of their specific section's documents is complete and areas of further research/docs have been identified
- Zoom Check in for Team: Documents and who will meet with who and when they will be on site
- August 4: Members send additional questions to Probation for areas where there
 are additional questions and staff requests to meet. Probation provides names of
 those staff who are appropriate to meet with.
- August 11: Probation sends responses to questions
- August 13: Team Meeting for final preparations for on-site inspection
- August 11: Team members advise staff of who they want to speak to with to Probation and days/times they will be there
- Week of August 19: members meet with youth to explain process and prep for on-site visit and interviews
- Two days the week of 8/25/25: Team Members on site
- September 8: Team members have completed data input and narrative write up of commendations and recommendation for their areas in the draft report
- September 10: ZOOM call to review draft report
- September 19: Draft Narrative and Checklists complete and sent to Probation
- September 26- Probation Feedback to Committee fis received
- Septemer 29: Zoom call to review response & determine what changes might be made base upon Probation's feedback
- October 3: Final draft completed and submitted for JJDPC October meeting packet
- October 9: Final Report in Commission Packet for Action/Approval so it can be sent to Probation for their submission to BOS (November meeting is too late to make December BOS meeting)
- Probation adds their cover letter and sends final report to BOS (about 6 weeks in advance) to ensure that it is on the BOS Agenda no later than December 2024
- December Report is in the BOS packet and sent to the BSCC
