UPDATE #3: COUNTY LAUNCHES SOUTH COUNTY ROAD WORK FOR ANNUAL ROAD MAINTENANCE PROGRAM

August 25, 2025 – Santa Cruz, CA— The County of Santa Cruz Department of Community Development & Infrastructure (CDI) is launching the final phase of patch paving work for the Annual Road Maintenance Program in South County on Monday, August 25.

South County patch paving is scheduled for August 25–October 24 and includes:

- August 25-September 4: Green Valley Road (Pioneer Road to Sans Road)
- **September 5–12:** Eureka Canyon Road (2013 Eureka Canyon Road to Dove Lane)
- **September 15–26:** Casserly Road (Whiting Road to Green Valley Road)
- September 29-October 10: Calabasas Road (Bradford Road to Koenia Road)
- October 13-17: Buena Vista Drive (650 Buena Vista Drive to Larkin Valley Road)
- October 20–24: San Andreas Road (Playa Boulevard to Seascape Boulevard)

Crews will work on weekdays only from 8:30 a.m. to 4 p.m., with traffic control measures in place to ensure safety and minimize disruptions.

"We're wrapping up another successful season of critical road maintenance," said CDI Director Matt Machado. "This final phase in South County ensures we've addressed priority road segments throughout our unincorporated areas before the winter season arrives."

This announcement completes the County's comprehensive three-phase approach to the 2025 Annual Road Maintenance Program, following successful paving operations in Mid-County areas that began in April and North County work completed in August, as part of the County's 27-week seasonal maintenance window.

"Our systematic approach allows us to maximize our resources and deliver the most impactful improvements to roads that serve our communities daily," said County Roads Superintendent Alex Sandoval. "We prioritize safety, accessibility, and how each road connects to the broader transportation network."

All work is part of the County's Annual Road Maintenance Program and is funded by the Highway Users Tax Account (HUTA), commonly known as the Gas Tax.
